



IN-CAB INSPECTIONS.

(Truck Start) Now only 2 warning lights working, Seat belt and parking brake. (if any other warning light is showing, mention that as well.)

GAUGES- All Gauges are Working, Primary pressure gauge is working pressure is 110 PSI and it is in operating range, Secondary pressure gauge is working, pressure is 110 PSI and it is in operating range.

STEERING- Steering no crack no damage, turns left properly, turns right properly, no free-play, fully attached to the body.

MIRRORS & GLASSES- Both hood mirrors, both side mirrors, blind spot mirror, no crack no damage clear visibility & adjusted to my seat, Both side glasses and both rear glass no crack no damage clear visibility, windshield no crack no damage clear visibility.

WINDSHIELD WIPERS- Both Wiper & wiper blade no cut no crack no damage, washer fluid is working, both wiper speed working 1, working speed 2, working speed 3. Both Wiper & washer fluid works on all speeds & provide me clear visibility.

DEFROSTER- Mode is on defroster, maximum heat, defroster is working speed 1, working speed 2, working speed 3 & working speed 4. defroster is working on all speed with maximum heat and provide the clear visibility.

DRIVER SEAT- Seat no cut no crack no damage, locks properly, attached to tractor body & adjusted to all the mirrors, **Seat Belt- buckle** both buckles no crack no damage, fasteners tight and secure, seat belt locks properly, seat belt no cut no crack no damage, no free-play, Seat belt unlock properly, **hook** no crack no damage fastener tight and secure, Both Side **Tether belt** no cut no crack no damage, all fastener tight and secure.

SAFETY/EMERGENCY equipment.

I have three safety devices in my truck, **Fire extinguisher/cylinder** is beside passenger seat safe & secure, fully charged, ready to use, no expire, **FIRST AID KIT** (*Touch First-Aid Kit*) safe & secure, fully equipped, no expire, ready to use, **REFLECTIVE TRIANGLE** (*Touch Triangles*) No crack no damage, ready to use, safe & secure.



KEY POINTS:

At the end of you performing your full inspection your examiner will ask you 2 questions. Perform the questions as you did earlier and remember to read your Minor & Major defects from Schedule 1 for the question you performed ONLY.

The examiner asks you 5 question which are

- 1. Driver Seat*
- 2. Emergency equipment & Safety devices*
- 3. Heater / Defroster*
- 4. Glass & mirrors*
- 5. Windshield Wiper / Washer*
- 6. Passenger Apartment*

- When asked question of DRIVER SEAT, you must also perform seat belt and tether belt.
